Αξιότιμε κύριε Πρωθυπουργέ,

Το Διοικητικό Συμβούλιο της ΕΣΗΕΑ εκφράζει την έντονη ανησυχία του για τα τεκταινόμενα στη Λευκορωσία, όπου, με αφορμή τις πολιτικές εξελίξεις, περισσότεροι από 25 δημοσιογράφοι συνελήφθησαν τις τελευταίες ημέρες και πάνω από 200 έχουν δεχθεί επιθέσεις.

Οι δημοσιογράφοι και τα ανεξάρτητα Μέσα στη Λευκορωσία εργάζονται ήδη υπό εξαιρετικά δυσμενείς συνθήκες. Η τοπική ένωση των δημοσιογράφων «Οργάνωση Δημοσιογράφων Λευκορωσίας» (BAJ) επισημαίνει ότι δεν έχουν παρατηρηθεί ξανά τόσο βίαια επεισόδια εις βάρος των δημοσιογράφων, όπως αυτά που εκδηλώθηκαν πρόσφατα.

Το Διοικητικό Συμβούλιο της ΕΣΗΕΑ ενώνει τη φωνή του με τη Διεθνή και την Ευρωπαϊκή Ομοσπονδία Δημοσιογράφων και επιθυμεί να σας ενημερώσει για τα όσα πρωτοφανή συμβαίνουν, τα οποία συντελούν στην κατάφωρη καταπάτηση της ελευθερίας του Τύπου. Η ΕΣΗΕΑ, ιδρυτικό μέλος της Διεθνούς Ομοσπονδίας Δημοσιογράφων από τη δεκαετία του 1920, διαχρονικά πρωτοστατεί στα θέματα της ελευθερίας της έκφρασης. Για αυτό το λόγο, το 2019 υπερψήφισε στο Παγκόσμιο Συνέδριο της Διεθνούς Ομοσπονδίας Δημοσιογράφων, την εφαρμογή του «Παγκόσμιου Χάρτη Δημοσιογραφικής Δεοντολογίας».
